

Tenders and Projects

IREDA signs performance MoU with MNRE for 2025-26

IREDA has signed a performance-linked MoU with MNRE for FY 2025–26, setting a revenue-from-operations target of ₹8,200 crore (up from ₹6,743 crore in FY 2024–25) and reinforcing KPIs like ROCE, NPA ratios, asset turnover, and EBITDA (Powerline)

NGEL commissions 50 MW solar capacity at Bhuj

NTPC Green Energy (NGEL) has commissioned 50 MW of solar capacity (part of the 150 MW Bhuj project) through its Ayana subsidiary, boosting the group's total green energy portfolio to 7,247.575 MW. The plant began commercial operation on August 24, 2025 (Powerline)

Andhra Pradesh cabinet approves 250 MW solar project

Andhra Pradesh has approved a 250 MW solar project in Mylavaram's Kadapa district, allocating 1,200 acres of government land leased for 33 years to Adani Solar Energy. This move builds on the state's expanding renewable push, which includes a 4.8 GW solar module manufacturing facility and multi-pronged clean energy investments (Powerline)

SECI tenders 3.5 MW rooftop solar projects in educational institutions

SECI has floated a 3.54 MW rooftop solar tender under the RESCO model for educational campuses across the Northeast, including institutions like SMU (Tadong & Majhitar), IIIT Guwahati, MU Imphal, and IIT Guwahati. Bids are open until October 3, 2025 (Mercom)

MP taps ₹56,414-cr investment, targets 50% green power by 2030

Madhya Pradesh received proposals totaling ₹56,414 crore at the Katni Mining Conclave—with Singhal Business Pvt. Ltd. pledging ₹15,000 crore for coal gasification and clean energy projects, supporting the state's goal to raise renewable energy's share in its power mix to 50% by 2030 (SaurEnergy)

Insights

India's coal import rises in June quarter

India's coal imports rose by 1.5% year-on-year in Q1 FY 2025–26, reaching 76.4 million tonnes, while domestic production from Coal India dropped 8.5% in June due to monsoon-related disruptions (LiveMint)

Three considerations to make green hydrogen a reality in India

India's green hydrogen growth hinges on three priorities: building cost-competitive renewable supply, creating supportive financing and policies, and scaling end-use demand across industries (RMI)

Regulatory Update

APERC draft amendment aims to strengthen rooftop solar with net metering reforms

Andhra Pradesh's electricity regulator has issued a revised draft modifying rooftop solar rules to introduce virtual and group netmetering, streamline processes via DER aggregators, and rationalize fees—from zero for ≤5 kW systems up to ₹25,000 per MWp—aiming to boost rooftop solar adoption under its Integrated Clean Energy Policy (Energetica)

International News

India and Japan strengthen energy cooperation through ministerial dialogue

India and Japan, under the Japan—India Clean Energy Partnership, held a ministerial-level energy dialogue where they affirmed commitments to energy security, clean energy transition, and enhanced cooperation on clean hydrogen, CCUS, ammonia, biofuels, and advanced energy technologies (PIB)
